Evaluation of type-B RR dimerization in poplar: a mechanism to preserve signaling specificity?

15 Abstract

Plants possess specific signaling pathways, such as the MultiStep Phosphorelay 16 17 (MSP), which is involved in cytokinin and ethylene sensing, and light, drought or osmotic stress sensing. These MSP comprise histidine-aspartate kinases (HKs) as receptors, histidine 18 phosphotransfer (HPts) proteins acting as phosphorelay proteins, and response regulators 19 20 (RRs), some of which act as transcription factors (type-B RRs). In previous studies, we identified partners of the poplar osmosensing signaling pathway, composed of two HKs, three 21 main HPts, and six type-B RRs. To date, it is unresolved as to how cytokinin or osmotic stress 22 signal specificity is achieved in the MSP in order to generate specific responses. Here, we 23 present a large-scale interaction study of poplar type-B RR dimerization. Using the two-24 hybrid assay, we were able to show the homodimerization of type-B RRs, the 25 heterodimerization of duplicated type-B RRs, and surprisingly, a lack of interaction between 26 some type-B RRs belonging to different duplicates. The lack of interaction of the duplicates 27 RR12-14 and RR18-19, which are involved in the osmosensing pathway has been confirmed 28 by BiFC experiments. This study reveals, for the first time, an overview of type-B RR 29 dimerization in poplar and makes way for the hypothesis that signal specificity for cytokinin 30 or osmotic stress could be in part due to the fact that it is impossible for specific type-B RRs 31 to heterodimerize. 32

36 1 Introduction*

37

All organisms interact with their environment, and any modification to this 38 environment must be perceived in order to allow them to adapt to changes, and therefore 39 ultimately for them to survive. Bacteria, archaea, fungi, and plants share a common group of 40 signaling proteins. These proteins are involved in a wide range of fundamental developmental 41 processes and are able to sense environmental changes, thereby inducing gene regulations 42 43 leading to adaptive response. The prototypical bacterial signaling pathway, or the Two-Component System (TCS) comprises a Histidine Kinase (HK) sensor protein characterized by 44 45 a Transmitter Domain (TD), and its cognate response regulator (RR) which contains a Receiver Domain (RD) [2]. A variant of this TCS exists in bacteria and is called a MultiStep 46 47 Phosphorelay (MSP). This pathway is initiated by a hybrid type HK with an RD fused to its C-terminus end. These proteins act as homodimers and autophosphorylate by inter- or intra-48 49 molecular reactions, and the phosphate residue is transferred by the TD to the RD. The phosphoryl group is then shuttled to a Histidine Phosphotransfer (HPt) protein, and from there 50 51 to a terminal RR [10,2]. In plants, the MSP signaling pathway is involved in phytohormone signal transduction, such as cytokinin and ethylene signaling [34,47], red light responses via 52 phytochrome receptors and in osmosensing via osmosensors [2,58,59]. There are four types of 53 RRs in plants: type-A, type-B, type-C and pseudo RRs. Type-C RRs present a similar 54 structure to the type-A RRs, with a receiver domain, but their gene expression is not induced 55 by cytokinins, unlike type-A RRs. Type-A and -B RRs are both involved in the cytokinin 56 signaling pathway. The last group is composed of pseudo-RRs which lack the canonical 57 histidine phosphorylation site in their RD and are involved in circadian rhythm [40,24]. 58

Out of all these RRs, type-B RRs are clearly characterized as transcription factors due to the 59 presence of a DNA-binding domain and a transactivation sequence in the carboxy-terminal 60 end. They are widely involved in the transcriptional regulation of cytokinin-dependent genes, 61 62 and control intrinsic developmental plant programs, or responses to abiotic stresses, and biotic interactions involving cytokinins [31,32,62]. For instance, in Arabidopsis, ARR2 is known to 63 be involved in shoot development [11], and ARR1 and ARR12 in cell division and 64 differentiation of the root meristem [12,43]. However, their possible involvement in 65 osmosensing and the transcriptional control of osmotic-responsive genes have not yet been 66 67 addressed.

These transcription factors are found in all organisms, from unicellular green algae 68 69 such as Ostreococcus tauri and Chlamydomonas reinhardtii, to higher plants [48]. They are composed of an RD characterized by the conserved D-D-K motif and a large C-terminal 70 71 extension including a Myb-like DNA-binding domain, called the GARP domain or B motif, followed by a glutamine-rich transactivation domain [51,52,28]. 72

In the plant cytokinin signaling pathway, these transcription factors regulate the 74 phytohormone signal through the RD, since this domain is thought to inhibit the DNA-75 binding activity of the GARP domain in the absence of the phosphorylated Aspartate residue associated with cytokinin signaling [52,53,34,56,20,50,36]. HPt proteins phosphorylate an 76 Aspartate conserved residue in their RD of the transcription factor, which leads to its 77 78 activation and transactivation capacity.

In bacteria, almost all RRs are able to homodimerize through the RD (RR_{RD}), and are 79 characterized by a structure composed of five α helix and five β sheets [57,17,39,10,5,64]. In 80 these prokaryotic organisms, RR dimerization is known to promote DNA binding and 81 transcription activation. Only homo-dimerization has been selected during evolution, as no 82 83 evidence of physiologically relevant heterodimerization was observed [10]. Furthermore, RR homo-dimerization is typically accompanied by the RRs having an increased affinity for 84 85 specific DNA-binding motifs and then typically required for output generation [64].

86 In plants, the crystal structure of three HK RDs (HK_{RDs}), namely $AHK5_{RD}$, $ETR1_{RD}$ and CKI1_{RD}, have been determined [4,44,45]. These data revealed a high level of structural 87 conservation between plant HK_{RDs} and bacterial RR_{RDs}, with dimerization interfaces 88 characterized by the $\alpha 4-\beta 5-\alpha 5$ region [18,46]. Other studies reported HK and HPt 89 dimerization in Arabidopsis and in rice [13,14,21,49,63,54]. In poplar the two HK1 90 osmosensors (HK1a and HK1b) linked to drought perception were shown to be able to 91 homodimerize [26,7,27]. However, only a few studies concerning RR dimerization have been 92 conducted, due to the strong auto-transactivation capacity of the type-B RRs in the yeast two-93 hybrid system (except for the homo-dimerization of ARR14, ARR18 and heterodimerization 94 95 between ARR14 and ARR2 [13,30]). While RR homo-dimerization process is well 96 established in bacteria, similar data in plants are missing.

Among the 11 type-B RRs of Populus trichocarpa genome, we previously isolated 98 nine RRs (RR12-RR16, RR18-19, RR21-22) from Populus deltoides (Bartr.) Marsh x P. 99 nigra L. Dorskamp genotype and determined that RR12-14, RR16, and RR18-19 could be 100 involved in the osmosensing signaling pathway controlled by HK1 osmosensors [6,7]. 101

In the present work, our aim was to provide an overview of homo- and 102 heterodimerization of these type-B RRs in poplar. We studied protein-protein interactions for 103 all type-B RRs isolated from this plant model by performing yeast two-hybrid (Y2H) assays. 104 In the case of a lack of interactions being observed with this technique, we studied these 105 potential interactions using Bimolecular Fluorescence Complementation (BiFC) assay in plant 106 cells. When combined, our results showed homo-dimerization for all type-B RR proteins. As 107 type-B RRs are duplicated genes, the heterodimerization within each corresponding protein 108 pair (intra-pairs) was also observed. On the other hand, heterodimerization of RRs belonging 109 110 to different pairs (inter-pairs) was not observed systematically, revealing that some duplicated gene products were unable to interact. This study is the first to give a full overview of plant 111 112 type-B RR dimerization and leads us to hypothesize that heterodimerization, at least in plants, could be a way of modulating the signal specificity induced by the HK sensor. 113

115 2 Material and Methods

116

117 2.1 Yeast two-hybrid (Y2H) assays

118

The Y2H assays were performed using a LexA DNA-binding domain encoding bait 119 vector (pBTM116 referred as pLex) and a Gal4 activation domain encoding prey vector 120 (pGADT7, Clontech). DDK domains from each B-type RR were cloned into the pLex and 121 pGAD vectors as XmaI-SalI and XmaI-XhoI fragments respectively. The yeast strain L40A 122 (MATa ade2-101 his3-200 leu2-3,112 trp1-901 ura3-52 LYS2::(lexA op)x4-HIS3 URA3:: 123 (lexA op)x8-lacZ gal4 Δ) and Y187 (MAT α gal4 Δ gal80 Δ ade2-101 his3-200 leu2-3,-112 trp1-901 124 ura3-52 URA3::GAL1UAS-lacZ met-) was used for transformations with pLex and pGAD 125 constructions respectively, according to the lithium acetate method [19]. Transformed yeasts 126 127 were selected onto a trytophan (-W) or leucine (-L) lacking medium for 3 to 4 days at 30°C. MATa and MATa yeasts were then mated and resulting diploids were selected onto -LW 128 129 medium. For each diploid strain, an overnight cell culture with Optical Density wavelength of 600 nm (OD₆₀₀) of 0.2 and three dilutions (1:10, 1:100 and 1:1000) were prepared. Five 130 microliters of each cell suspension were dropped onto -LW control medium and -LW -His (-131 LWH) interaction selective medium. Yeast cells grew for three days at 30°C for the growth 132 test and were then tested for LacZ activity. X-Gal tests were performed according to the 133 overlay method derived from Fromont-Racine [16] by applying 10 mL of X-Gal mixture 134 (0.5% agar, 0.25 M phosphate buffer, 0.1% SDS, 0.04% X-Gal) onto -LWH plates. The blue 135

136 color was estimated after 5 hours of incubation at 30°C. Thus, all interactions were tested 137 using two reporter genes (*HIS3* and *LacZ*) and at least twice with 8 positive yeast clones. 138 Negative controls were performed using mating between each MATa (pLexDDK) and MATa 139 (pGADØ) yeast.

142 2.2 Bimolecular Fluorescence Complementation (BiFC) assays

143

BiFC assays were conducted using the pSPYCE(MR) [61] and pSPYNE(R)173 144 plasmids (23) which allow the expression of a protein fused to the C- or N-terminal of the 145 146 split-yellow fluorescent protein (YFP) fragments, respectively. The full length coding sequences from RR-12, -14, -18 and -21 were cloned as Sall-KpnI fragments and those from 147 148 RR-13, -19 as SpeI-SpeI fragments. Each RR was cloned in frame with the N-terminal fragment (pSPYNE(R)173) and the C-terminal fragment (pSPYCE(MR) of YFP. Transient 149 150 transformation of *Catharanthus roseus* cells through particle bombardment and YFP imaging were performed according to Guirimand [22] with adaptation for BiFC assays [23]. 151

153 **3 Results**

154

3.1 Dimerization screen of type-B RRs from Dorskamp poplar genotype

156

A Y2H system was used to study interactions between the nine isolated type-B RRs 157 from the Dorskamp poplar genotype (Figure 1). Yeast growth observed on the non-selective 158 medium (-LW) indicates the success of the cell co-transformation in all tested conditions. For 159 all pLex-DDK-RRs tested with pGAD empty vector as a negative control, no auto-activation 160 was observed. On interactive-selective medium (-LWH), the analysis showed homo-161 dimerization of the nine tested type-B RRs, revealed by the activation of at least one reporter 162 163 gene. Except for yeast expressing RR15, yeast growth on -LWH medium revealed strong interactions for all homo-dimerizations. 164

With the exception of RR22, RR genes are duplicated in the poplar genome, thus constituting pairs of RRs (Fig S1). The Y2H study revealed interactions between all type-B RRs from intra-pair genes studied (RR12/RR13, RR14/RR21, RR15/RR16, RR18/RR19). Interactions were also detected between RRs from inter-pair genes, although each RR within a pair did not show the same interaction pattern. For example, within the RR12/RR13 pair,

RR12 interacted strongly with RR15 and RR16, whereas RR13 only interacted strongly with 170 RR16. In the same way, within the RR14/RR21 pair, only RR14 was able to interact with 171 RR15 and RR16. More interestingly, a complete lack of interaction was observed between 172 some inter-pair RRs such as between RR12/RR13 and RR14/RR21, and also between 173 RR18/RR19 and RR14/RR21, whatever the configuration tested (prey or bait configuration 174 for all RRs tested). Moreover, among the six type-B RRs identified as partners in the poplar 175 osmosensing pathway (RR12, RR13, RR14, RR16, RR18 and RR19), only RR16 was able to 176 interact with all five of the other RRs since a clear lack of interaction was observed in some 177 178 cases. All data are summarized in table S1.

3.2 Validation of the interaction screen of osmosensing type-B RRs by a BiFC analysis 181

182 Due to a lack of interaction between some RRs belonging to different pairs involved in the poplar osmosensing pathway (RR12/RR13:RR14 and RR18/RR19:RR14) being observed 183 184 in the Y2H analysis, a BiFC analysis was conducted in order to validate this specific RR's behavior. Firstly, as previously observed by the Y2H assay, the homo-dimerization of RR12, 185 186 13, 18 and 19 was validated using the BiFC approach (Figure 2) but not for RR14 (Fig S2). 187 Similarly, the heterodimerization for the intra-pairs, RR12-RR13 and RR18-RR19 was confirmed (Figure 3). Interestingly, using this BiFC approach, we detected an interaction 188 between RR13/RR18 and RR14/RR12 which was not previously observed in the Y2H assay 189 (Figure 4, Figure 5A). Finally, the complete lack of interaction shown by the Y2H assay was 190 confirmed using the BiFC approach between RR14 and the RR18-RR19 pair (Figure 5I and 191 5M), as well as between RR14 and RR13 (Figure 5E). All these data allowed us to draw up a 192 dimerization map of poplar type-B RRs (Figure 6). 193

195 **4 Discussion**

196

In Arabidopsis, the dimerization of HKs has been reported for cytokinin receptors (AHK2, 3, 4 and 5), CKI1, the ethylene receptor (ETR1), and for AHK1 [13,25,9,44,45,4]. Expressed in *Nicotiana benthamiana*, AHP1 to 3 are also able to homodimerize [37]. With the exception of the homo-dimerization of ARR14, ARR18 and the heterodimerization between ARR14 and ARR2, only scarce data are available concerning RR dimerization in plants [13,42,30]. Recently, in bacteria, it has been shown that heterodimerization could be used to integrate signals from two distinct developmental pathways [1]. Such a system using RR homo- or hetero-dimerization could also be used in plants as part of the response specificity toabiotic stresses.

In plants, HKs are signal specific receptors, with AHK2 to 5 involved in cytokinin 206 signaling, ETR1 in ethylene signaling and AHK1 in putative osmosensing in dehydration 207 208 avoidance and low water-potential responses [58]. However, using the same HPt and RR 209 proteins as partners, the question of signal specificity conservation is raised. In poplar, the lack of interactions between osmosensors HK1, and cytokinin receptors HK2 to 4, suggests 210 that interconnection between the two signaling pathways may not be mediated by direct HK 211 212 hetero-dimerization [27]. Moreover, some HPt proteins have been shown to be specific to cytokinin signaling or common to both osmotic stress and cytokinin signaling [27]. These 213 214 results suggest that some HPt proteins could participate in the preservation of the signal specificity. In this case, type-B RRs must also participate in this preservation via homo-215 216 and/or hetero-dimerization. It seems that a deeper understanding on how MSP elements oligomerize would allow us to determine the functional importance of homo- and hetero-217 218 dimerization in plant MSP signaling regulation.

In the Dorskamp poplar genotype, we previously isolated nine type-B RRs, RR12-16, 219 220 18-19, 21 and 22. Based on interaction studies between these RRs, and HPt protein partners of 221 the HK1 receptor, and the co-expression analysis of transcripts of these potential partners in poplar organs, only six of them (RR12-14, 16, 18-19) have been retained as potentially 222 involved in drought response [7,8]. In this work, we showed the homo-dimerization for all 223 type-B RRs and the heterodimerization in each RR pair. However, surprisingly, among the six 224 type-B RRs belonging to the HK1 pathway, some RRs are unable to interact with each other, 225 such as RR18-19 with RR14. As reported for interaction study between R and GL3 ACT 226 domains by Y2H assay, it is difficult to assess interactions with Kd values above 400 nM [35]. 227 In order to assess the robustness of the Y2H results for RR14, we used a second in vivo 228 229 method, the BiFC assay, to study protein-protein interactions (PPIs). Then we showed a weak interaction between RR12 and RR14 but observed once again a lack of interaction between 230 231 RR13, RR18 and RR19 with RR14. The use of this second method combined with that of the Y2H makes it possible to reinforce the idea of an absence of interaction between RR14 and 232 the three other RR13, 18 and 19. Consequently, RR14 is the least interactive RR from this 233 group of six RRs, as it only interacts with RR12 and RR16. In Arabidopsis, ARR11, 234 homologous to the poplar RR14, is a positive transcriptional regulator of the cytokinin 235 signaling pathway [53,34,56] and is involved in biological processes controlled by cytokinins, 236 237 such as root stem cell maintenance [38].

Recently, it has been shown that ARR11 was able to interact with the Sucrose 238 nonfermenting1-related kinase 2.6 (SnRK2.6), a key kinase of the ABA signaling pathway 239 which is also involved in stomata closure and regulation of ABA-responsive genes leading to 240 drought tolerance. It has been shown that this interaction repressed the kinase activity of 241 242 SnRK2.6. Finally, ARR11 is a negative regulator of drought stress tolerance as it inhibits SnRK2.6. However, it is a positive regulator of plant growth development induced by 243 cytokinins in normal conditions [29]. At the same time, it has been shown that ARR18, 244 homologous to the poplar RR18, is able to interact with the transcription factor bZIP63, which 245 246 is a negative regulator of seed germination upon osmotic stress. This interaction interfered negatively with the transcriptional activity of bZIP63 on the PDH1 promoter. This study has 247 248 led to the conclusion that ARR18 is a positive osmotic stress RR in Arabidopsis seeds [60]. Interestingly, in Arabidopsis, ARR11 and ARR18 are negative and positive regulators of the 249 250 drought stress response, respectively. In poplar, RR14 and RR18-19 (homologous to ARR11 and ARR18 respectively) are unable to interact with each other. The biological function of 251 252 these poplar RRs has not yet been determined. However, RR18 could only be isolated in drought stressed leaves and is up-regulated by osmotic stress [8]. 253

254 Altogether, the specificity in transcription factor dimerization could be an efficient 255 mechanism for avoiding unwanted crosstalk between pathways. Indeed, transcription factors of signaling pathways involved in antagonistic developmental processes, such as growth 256 257 maintenance versus drought tolerance could have the same spatio-temporal expression pattern, and in this case the dimer specificity could avoid unwanted signaling crosstalk and 258 maintain specific responses [3, 55]. The lack of interaction observed in our study between 259 RR14 and RR18-19 could participate in the maintenance of this specificity. Indeed, poplar 260 RR18 and probably also RR19 could be involved in drought tolerance in the same way as 261 their Arabidopsis counterpart ARR18, and poplar RR14 could be involved in the cytokinin 262 signaling pathway and plant growth development in the same way as its Arabidopsis 263 counterpart ARR11. In this case, the lack of interaction between them could be particularly 264 265 important in order to participate specifically in the trade-off between plant growth and stress tolerance. Neofunctionalization, and the forming of heterodimers may be considered as an 266 example of subfunctionalization [63]. 267

Drought stress is one of the environmental stresses which has the most impact on plants. To cope with water-deficit conditions during the current global warming, plants will have to adapt to increasing drought stress events by regulating a variety of physiological processes. In

this context, the efficiency of the signaling pathway involved in the trade-off between plant 272 growth and stress adaptation will play a crucial role. The maintenance of specificity in 273 signaling pathways (including the cytokinin pathway) is a key point in this balance. In our 274 study, although the homo- and heterodimerization of the paralogs of type-B RRs were 275 expected, the lack of interaction between some specific type-B RRs inter-pairs was not. It is 276 now well known that gene duplication and divergence is a major mechanism of the 277 evolutionary process by which new proteins and functions emerge in biology, and provide 278 cells with diverse functions. However, regulatory complexity and additional specificity can 279 280 arise through other mechanisms, such as through homodimeric or heterodimeric interactions [41]. To establish new and insulated pathways, substitutions that eliminate the 281 282 heterodimerization of the diverging paralogous proteins, while maintaining homodimerization are needed [10]. Our study suggests that the specificity conservation could be due, in part, to 283 284 the fact that it is impossible for specific type-B RRs to heterodimerize. However, this hypothesis needs to be further validated. As has been done for bacteria, a global study of 285 286 conserved residues at the dimerization interface characterized by the $\alpha 4-\beta 5-\alpha 5$ region would help us to better understand how plants could maintain a specific response to cytokinin or 287 288 drought stress using such a signaling pathway.
